FINANCE OPTIONS

FAC offers a range of financial products, tailored for growing sustainable First Nations businesses. These products focus on patient and flexible capital options including:

- Seed Grants;
- Concessionary Loans;
- Project finance;
- Working Capital;
- Secured and Unsecured Lending.

FAC has the ability to lend a First Nations business up to \$1 million through our financing options, subject to serviceability and limits for first round finance, caps apply. Establishment fees may be payable on eligible loans. All businesses are subjected to a screening process to determine the amount of capital that the business can take on.

FAC is here to equip businesses for long-term success by using financing to support growth and sustainability and also provides business support to eligible businesses.

BUSINESS STRATEGIC ADVISORS
